RESOLUTION No. 12-2019 CRA; A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF STUART, FLORIDA, AUTHORIZING THE BOARD CHAIR TO EXECUTE AN AGREEMENT BETWEEN THE STUART COMMUNITY REDEVELOPMENT AGENCY AND THE GILT COMPLEX, FOR A MURAL MATCHING GRANT IN THE AMOUNT OF \$2,000 TO INSTALL MURAL ON THE EXTERIOR NORTH WALL OF THE GILT COMPLEX BUILDING; PROVIDING AN EFFECTIVE DATE; PROVIDING FOR CONDITIONS OF APPROVAL; AND FOR OTHER PURPOSES.

Pinal Gandhi-Savdas, CRA Administrator, presented on the mural proposal. The mural was reviewed and supported by the Martin County Arts Council and Community Redevelopment Board. Mural expected to begin in January 2020 and be completed by March 2020.

Applicant, Duncan Heard, owner of the Gilt Complex, came forward to answer questions and discuss the grant funding. Students of Martin County High School will assist in the mural with teacher supervision.
