6. CONTEMPORARY ART EXHIBIT IN GAZEBO PARK BY SUSAN KORES, CRA MANAGER, MARTIN COUNTY

ORDINANCE No. 2439-2020; AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, AMENDING THE CITY OF STUART'S COMPREHENSIVE PLAN VIA A SMALL-SCALE COMPREHENSIVE MAP AMENDMENT FROM RESIDENTIAL LOW TO EAST STUART; REZONING FROM RESIDENTIAL, SINGLE-FAMILY (R-1) TO SINGLE-FAMILY AND DUPLEX SUBDISTRICT (SFD) ON THE CITY'S OFFICIAL ZONING MAP; AND APPROVING A MAJOR URBAN CODE CONDITIONAL USE FOR PROPERTY TOTALING 0.72 ACRES, OWNED BY LONE PALM PROPERTY INVESTMENTS, LLC, LOCATED BETWEEN MARTIN LUTHER KING JR. Six (6) six people sworn in; Kevin Freeman and Stephen Mayer of the City of Stuart, Don Cuozzo of Conceptual Design Group. Janet Hartman, Rick Hartman, and Reed Hartman of Lone Palm Development.

Stephen Mayer presented with a power point providing the future land use, zoning, the site plan, and the CRA and staff recommendations.

Don Cuozzo provided a brief presentation with a neighborhood overview and comparison of surrounding properties with suggested modifications to the plan.

Reed Hartman commented on the new construction points.

Discussion took place on the East Stuart Land Use Code and the requirements.

SEMINOLE STREET, SAID LAND BEING MORE FULLY DESCRIBED IN EXHIBIT "A" ATTACHED; ESTABLISHING THE SAILFISH COVE UPUD CONSISTING OF THIRTY (30) MULTI-FAMILY RESIDENTIAL UNITS AND 5,768 SQUARE FEET OF OFFICE/COMMERCIAL USE IN ACCORDANCE WITH THE SECTION 2.07.00 STUART LAND DEVELOPMENT CODE; ALLOWING A DENSITY OF 26.75 DWELLING UNITS PER ACRE ON A .925 ACRE SITE; APPROVING A FINAL SITE PLAN; PROVIDING FOR DEVELOPMENT CONDITIONS INCLUDING A TIMETABLE FOR DEVELOPMENT, DECLARING THE PLAN TO BE CONSISTANT WITH THE CITY'S COMPREHENSIVE PLAN; PROVIDING DIRECTIONS TO THE CITY CLERK; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

Five (5) people sworn; Kevin Freeman and Tom Reetz of the Development Department, Don Cuozzo of Conceptual Design Group, and Marcela Cambor of Marcela Cambor Associates.

Tom Reetz presented with a review including the location previously approved as the Seminole Bluff, the zoning, site, including four commercial office units and three residential floors with a Seminole Street streetscape plan. He provided a review of variances requested and conditions for development.

Marcela Cambor, Marcela Cambor Associates, provided an overview of the Sailfish Cove project in relation to the previous proposed Seminole Bluff. She discussed new project details which included parking.

Commissioner McDonald confirmed that charging stations be part of the approval.

Joe Captec, Captec Engineering, answered questions about parking, transportation study, water quality and drainage from the Commission.

Commissioner Matheson requested hard numbers for the charging stations to provided before next reading.

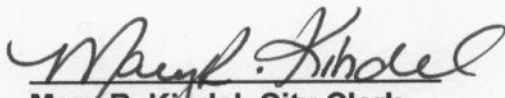

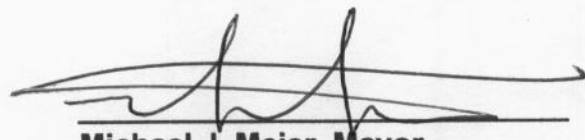
