DISCUSSION AND DELIBERATION

17. COMMUNITY RELATIONS BOARD

City Manager Dyess Recommendations:

Citizen initiated “Community Relations Board or Committee” made up of a City Commissioner, representatives of NAACP, ACES, Concerned Citizens of East Stuart, a Hispanic Organization, Ministerial Alliance, and two At Large positions. He as City Manager would personally facilitate the meetings and have staff present to address the meeting topic. Feels that the community distrusts the government and it would be best as a community board/ committee to meet and discuss topics.

Attorney Mortell explained from a legal perspective, if it were to be a City board it would be subject to Sunshine Law, limited to City residents, and would restrict participation and discussion.

Commission discussion included the benefits of an independent board, board members, target community areas, the purpose of the board, City facility meeting space, commissioner participation, and overall review of the City Managers plan.

Commissioner Bruner commented on a program done in Atlanta, GA in working with children, feels mentoring the children is important and a teaching portion for children on how to communicate with Police officers should be included.

Public Comment:


- 1) Amelia Fry – Hibiscus Ave.; Commented with support on Vice Mayor Clarke's Facebook post and read a letter in favor of a board designed to have open conversation about racism.**
- 2) Caitlynne Palmieri – Bonita St.; Member of the community that participated in writing the letter that Ms. Fry read and feels it is a powerful way to work together.**
- 3) Marissa Mensik – Collage St.; Complimented David Dyess on his idea and recommended, as a teacher, bringing youth into the board.**
- 4) Zoom – Alain Goindoo – Pine; In support of the board and asks that the board includes member of the school board.**
- 5) Zoom - Kate McCormic, Candice Rasa, Nancy Polites – Representatives of National Association of Social Workers (NASW) encourages consideration of representation from NASW, a social worker and/or a mental health worker as it's important to look at individuals and the community.**
- 6) Zoom – Tom Campenni – Commented on behalf of Vice Mayor Clarke, stating he feels she didn't do anything with malice.**

Commission discussion concluded in Commissioner Bruner representing the Stuart Commission on the Community Relations Board, the offer to utilize a City facility to host the meetings, and come back with a Resolution.

Public Comment:

- 1) Helen McBride – Comments that she prefers the East 10th Street Community Center is not used for the meetings until the COVID-19 virus is over in order to protect the children and the elderly.**
- 2) Caitlynne Palmieri – As a dues paying member of the NAACP and someone who works in East Stuart, commented that she would like to see Eula Clarke**

serve on the Board initially and thanked Commissioner Bruner for volunteering.

City Attorney Mortell reported briefly on his communications with Martin County on this matter and they have asked to fence the property in order to keep it secure. A chain link fence has been agreed upon around three sides and a decorative rod iron fence in the front.

City Manager Dyess reported on the FDOT measures taken and planned to open one side of the bridge.

Dixie Hwy. may be able to reopen but waiting for additional information.

Vice Mayor Clarke commented on the idea of creating a ferry. City Attorney Mortell reported that there is a river taxi that will be charging \$5.00 to transport people between the Tide House to the City Hall Dock.

16. EVALUATION AND APPRAISAL REPORT (EAR):

ORDINANCE No. 2442-2020; AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, ADOPTING THE EVALUATION AND APPRAISAL REPORT (EAR) FOR THE COMPREHENSIVE PLAN OF THE CITY OF STUART; STATING THE INTENT OF THE CITY COMMISSION TO AMEND THE COMPREHENSIVE PLAN BASED UPON RECOMMENDATIONS CONTAINED IN THE REPORT; AND APPROVING

Stephen Mayer, Development Department Senior Planner presented on the Evaluation and Appraisal Report, reviewing the process that began with staff review, public workshops, Joint LPA/Commission Meetings, now at the final stage holding a transmittal hearing for First Reading. The approved Ordinance after this reading will be transmitted to the State Department of Economic Opportunity, await their comments, then come before the Commission again for Second Reading and adoption. Mayer reviewed the areas of focus under transportation, housing, and conservation.


Mayor requested to strike word “geothermal” from Conservation Element, Gola Statement 5.A.

Clarke, noted page 5, Policy 2.A.19; wanted to ensure that the future transportation map series was the most up to date information available. Commented on a future road from Johnson Avenue for future discussions.

Mayor Meier commented on outdated names of recreation facilities/parks and requested the language be generalized. Intergovernmental should read “attainable” in place of “affordable”. New definitions for workforce housing and requests another review of the definitions in the Intergovernmental section.

Commissioner Matheson commented on the Infrastructure Element, remarking on the rain events and would like to push for more water retention.

2. MARTIN COUNTY EMERGENCY ORDER 20-11 (FACE COVERINGS)

City Manager Dyess briefly summarized Martin County's Emergency Order 20-11.

Mayor Meier commented that he has heard from many concerned members of the public and is in support of mandating face mask be worn by all (except children according to CDC guidelines) in the City.


Commissioner Matheson commented that though he agrees, he feels the Police Dept. has a lot to contend with at this time and adding a law that cannot be logically enforced could be putting our officers unnecessarily at risk.

City Manager Dyess explained enforceability, stating when conflict is created in telling citizens they can't do something and yet an officer must act and if resistance occurs, "the fight is on." He explained that every time a law is created, additional law enforcement/citizen contact is created that puts officers in contrary interaction with citizens, causing risk.

Discussion of face masks will be brought back for further discussion at the July 13th Commission Meeting and Police Chief Tumminelli will provide some information.
