# **Commissioner Bruner**

Commented on the river being so dirty.

#### **Commissioner Matheson**

 Agreed with Commissioner Bruner and reported on the status of Lake Okeechobee and his engagement with a PDT Meeting last week stating they are working with models to add in the effects of the discharges. Reported on the Army Corps position and will keep the commission updated. Announced a possible round-table discussion at the Flagler Center on December 17<sup>th</sup> to include some non-profits, Congressman Mast, Representatives Overdorf and

- Harrell, and some state representatives. Commissioners can attend but due to Sunshine Law, will not be speaking.
- Thanked all for serving at the Thanksgiving Feed at Gertrude Walden, especially the many Police Officers that participated.
- Announced he partook in a ride-along with Officer Jacobson last week and thanked Officer Ruediger and Officer Jacobson for setting it up, appreciated the perspective.
- Per COVID-19, in a day or two, Florida will hit a million cases milestone, stressed the importance of wearing masks.

#### **Commissioner McDonald**

- Wished all a Happy Thanksgiving and commented that is will be different than
  ones in the past but hopes it will be different from ones in our future. Noted
  on the Gertrude Walden Thanksgiving event and thanked especially the
  members of the Police Department.
- Martin County Realtors Association is hosting a Christmas Tree Event in Memorial Park beginning on December 12<sup>th</sup> and the City's Police Department is hosting an event in Flagler Park on December 22<sup>nd</sup>, excited to see the nice things the Police Department is doing for our community.
- Noted that he received a call from a business owner about commercial stormwater rates and the amount of increases over the past year, stated that they need to take these businesses into consideration when setting these rates in the future.

# **Vice Mayor Clarke**

- Echoes fellow Commissioner's comments about the river and masks and commented on the ribbon cutting ceremony of the Harbor Grove affordable housing project, glad to see the project moving forward.
- Commented with a suggestion that a City campaign to "mask up" as a reminder for our residents.
- Wishes all a Happy Thanksgiving, thankful for Thelma Washington, Sergeant Brian Bossio and all who helped in the Community.
- Likes the idea of the tree event in Memorial Park but wants to be careful to not encourage too large of crowds to gather.

Jim Chrulski, Community Services Director came forward to explain the event, that it will start on December 12<sup>th</sup> and end on the 26<sup>th</sup> so that people can come at their leisure and walk through the open area, not all on one night, allowing for thinner crowds. Asked if the Commissioners were interested in participating with a Commissioners Tree, they agreed.

Requested information on vaccine availability in Stuart.

David Dyess, City Manager replied that he has a Vaccination Implementation Plan conference call scheduled for the next morning.

#### **Mayor Meier**

- Wished all a Happy Thanksgiving.
- Encouraged by news out of the legislature by closing the online sales tax loophole which would benefit our local retailers, as Florida and Missouri are

the only states that have not updated to online sales tax collection and will be pushing for legislature to fight for that.

• Commented on the County's vote to increase the age for purchasing tobacco product from 18 to 21 and would like the City to address that.

City Attorney will bring back language in January. City Manager Dyess noted he is opposed to the licensing requirement of that and will speak with the Commissioners about that.

- Commented that he spoke with Candace Callahan and Rachel Snyder of Stuart Main Street and the Downtown Bucks was a success and he would like to further discuss the encouragement of this program, either with a D&D item or working with Stuart Main Street or using public sign boards.
- Masks encouragement, as numbers are increasing and commented on orders being given without enforcement.
- Announced that the Florida League of Cities ratified its Legislative Action Agenda and they are working on a draft Resolution that affirms the City's commitment to the FLC policy priorities.

Commissioner McDonald announced that he just received a message from Sue Hershey that her husband and former Mayor and Judge Hershey passed away and asked that they keep Ms. Hershey in their prayers.

#### **Commissioner Bruner**

Announced that she would like to add a comment and requested that Tyler Headway no longer works with the Stuart News but would like to send a thank you letter for his work on the St. Lucie River. Commissioners agreed.

## 7. UPDATE COMMUNITY INVESTMENT PROGRAM (CIP):

ORDINANCE No. 2458-2020; AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, AMENDING THE CITY'S COMPREHENSIVE PLAN TO UPDATE THE FIVE YEAR COMMUNITY INVESTMENT PROGRAM INCLUDED WITHIN THE CAPITAL IMPROVEMENTS ELEMENT OF THE COMPREHENSIVE PLAN; PROVIDING FOR THE REPEAL OF LAWS IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Stephen Mayer, Senior Planner of the City Development Department presented on the reason for the CIE update, reviewing the financial feasibility, and level of service standards.

Mayor Meier inquired if what we are expecting to spend over the course of 5 years could be included in the CIP to show under years 2 through 5.

Finance Director, Joly Boglioli came forward and reviewed the project categories, pulled up the budget and noted that some users are still not used to the new system. Some users included future years and others did not, so the data needs to be collected from the various departments. Some issues may be technological, but some may be because they are waiting on grants and those expenditures cannot be planned for.

By Second Reading, Mayor Meier requested conformation that the departments clarify the CIP Plan through the 5 years.

Commission and Mr. Boglioli briefly discussed plan projects such as the Water Plant RO Facility, Seminole Street, and grants. Additional topics reviewed included the Fiscal Policy Document and the Level of Service Table.

Mayor Meier expressed concerns over the traffic and asked what "E" means in LOS E. Stephen Mayer explained that there is a certain capacity of a roadway and the E means the roadway is not past the point that it is failing. Portions of US1 are exempt from LOS E. Martin County does trip counts every year and provides updates to let the City know the numbers.

Commissioner McDonald explained that this level of service is done by the MPO and this support is needed when looking to have changed made with the state as these changes can be challenging.

City Manager Dyess commented from a law enforcement perspective on the level of service and increase in density, in season, backups past Colorado happen regularly.
