Statement by City Manager Dyess:

Louis “Joly” Boglioli, Finance Director, presented with a power point presentation on the information the City has from the Property Appraisers Office, including the preliminary taxable value and CRA taxable value. Reviews included the Florida Retirement System adopted rates, TRICO Insurance increase, and the State of Florida revenue projections. Additional reviewed factors to consider are the impacts of COVID-19, multiple demands on federal funding, and impacts of civil activities of the insurance market.

Boglioli examined the primary revenue sources on a spreadsheet with the Commission.

 **4:32 PM City Manager Dyess noted that the City will be submitting to receive finding from the Cares Act Funding that the County has received, but can only apply for actual expenses incurred, not lost revenue. To his understanding, portions of that funding may be used for business rent and mortgage mitigation for citizens throughout the entire County.**
