**Commissioner Matheson commented that he would like to direct staff to use the AMI numbers of the County. Commissioners agreed.**


**Commissioner Glass Leighton commented that she is cautious about adding additional units because over time as units open, the City may find itself in a place where they have overbuilt.**


Mayor Meier stated that he is interested in working with developers on impact fees, parking, tree mitigation credits at a targeted amount.
