# **DISCUSSION AND DELIBERATION**

#### 17. DISCUSSION OF HOUSING POLICY AND INCLUSIONARY ZONING

Kev Freeman, Development Director presented on housing in Stuart. The presentation included the basis for residential density, a review of various projects from 2017 to present, living and workforce inflow/outflow in the City.

Discussion point – Does the City have the policies and resources to facilitate equitable delivery of housing? Freeman reviewed Inclusionary Zoning and provided an example and the effect of incentives, interventions, costs of the incentives, the program goal, time frame, costs, evaluation of benefits, monitoring of agreements,

#### **Public Comment:**

 Octavio "Oats" Retz – Waterlily PI.; Tent City Helpers, Homelessness, Commented on the only two categories of low and very low income. Noted a third income level not mentioned as extremely low income.

- 2) Rob Ranieri Flagler Ave.; Commented that the cost of doing business is far less than not. House of Hope, important to provide solutions and meet the needs of the community.
- Althea Whiley Diana Ter.; Concern for people in her community will have no place to go. Asks commission to consider to do something so no more people from the community get displaced.
- 4) Betty Brinkley Nassau Ave.; Commented the Commission displaced a lot of black people and when grants bring in new growth, new races will come in and they are all about the dollar, not human life.
- 5) Robin Cartwright Hibiscus Ave.; Commented that this is being made complicated because we can, to take this one piece at a time, use future land use for those who live here.
- 6) Hyson Douglas Bailey Ethan Terr.; Concerned with the lack of public affordable housing in Martin County. Any consideration for housing vouchers.
- 7) Jerry Gore Lake St.; Quoted scripture, will always have the poor among you. Commented on the rent he charges for the rooms he supplies according to their income for all races, encourages all to communicate with other members who
- 8) Gwendolyn Hall-Brinkley Majorca Ave.; Commented on why people chose to live in Port St. Lucie, is City of Stuart Housing Authority being managed by Ft. Pierce Housing Authority.
- 9) Helen McBride Flamingo Ave.; Stated she wanted an answer to Ms. Hall-Brinkley's question. This is our city and we can hold our own.

City Manager Dyess responded per the Stuart Housing Authority. City of Stuart only confirms who sits on the board and ratifies the board members, Ft. Pierce HUD manages the local authority. Everyone on the board is local to the City of Stuart. It was voted that City of Ft Pierce Housing Authority continue to run the Stuart Housing Authority.

Commissioners discussed the market dictating the cost of housing and that the control is not in the City's hands. Topics reviewed were supply and demand, overcoming increased density, impact fees, slowing down on projects, current quality of life.

Commissioner McDonald discussed that he always believed in bringing employers and brining money to the people of Stuart. The City has never built properties as there is no funding for building a large apartment complex. Maybe the City should pursue one project that is truly affordable housing.

Commissioner Meier discussed the multicultural crisis that Stuart is having. "What is Stuart?". Discussed how much density, what can Stuart handle (consumptive water users, school seats can be filled), we need to have real strong numbers behind it so the community can trust us. Also, need to account for future cost.

Vice Mayor Matheson agreed in parts with both Commissioner McDonald and Meier. Not an easy issue, does not think that inclusionary zoning is the way to solve housing issue. Spoke on adjusting density and impact fees and how it can affect the current residents of Stuart.

Think of quality of life for all people not just those who have a roof over their heads currently. Look into working with different programs and local people to ensure the Stuart residents are gaining.

City Manager Dyess noted that there is a developer that is interested in coming in and doing a true affordable housing development. The only issue they are having is finding land and parcel. Mentioned Housing Solutions who was looking at doing something similar more 'Workforce Housing". City manager also noted that our current code allows for credits to be given to a developer that is a true affordable housing developer.

Mayor Clarke asked about the 17 units per acre single also multi and PUD special zoning district in East Stuart. Inclusionary zoning is not the only way to go and agrees with the City Managers idea and figuring out what is that we need to study and what we can study to bring something into the city. I would like the idea of what potential build out would be if something like the zoning that had been proposed in giving the people potential to do more with their lots in East Stuart.

Mayor Clarke requested further public comment.

# **Public Comment:**

- 1) Nick Blount Sandpiper Ln.; Housing Solutions Council formed 3-4 years ago to address Workforce Housing. Break down the issue and have a workshop addressing each issue. Mentioned that his organization mission is to help families who make \$30,000 \$60,000.
- 2) Madeline Greenwood Letha Cir.; stated that hiring an outside facilitator could assist and build that trust with the residents. People from Palm Beach County are moving to Martin County as it is more affordable and taking local residents out because we are not making it affordable for our own residents to live here.
  - Mayor Clarke requested that Rob Ranieri think about speaking to the City Manager to talk about hosting the Poverty workshop.
- Rosalind Neiland Naranja Ave.; Has seen little change throughout all these years.
   Experience in Habitat for Humanity and spoke about the project that happened in Indiantown.
- 4) Paul Skyers Kanner Hwy.; Commented that all the affordable housing stems around financing; suggest changing the thought process and finance over a 50- or 55-year time frame.

Commissioner Meier noted that he firmly believes the community is stronger when the developer is made to include a percentage of affordable units, intermingling the wealthy with the non-wealthy instead of having social classes separated.

Vice Mayor Matheson stated we can look at other municipalities and talk to residents to see what we want to become and achieve affordable housing.

Mayor Clarke agrees with Ms. Greenwood and does not want to lose the character of the community instead build up our community. Would like to look into and investigate and deal with East Stuart.

Dyess summarized the discussion with the following: East Stuart specific moving forward with getting someone to help us establish a better relationship with the community or get an intervener with us in the community to move forward on the previous zoning ideas. Affordable housing: is to work with a developer that specifically address affordable housing rather than going into the inclusionary zoning. Market Rate: Only heard one commissioner speak on that, so we are still opened for business.
