ACRES OF LAND; "MULTI-FAMILY" TO "EAST STUART" FOR 4.50 ACRES OF LAND; "PUBLIC" TO "EAST STUART" FOR .53 ACRES OF LAND; AND "EAST STUART" TO "PUBLIC" FOR 5.16 ACRES OF LAND AS DEPICTED IN EXHIBIT "A" ATTACHED; DECLARING THE PLAN TO BE CONSISTENT WITH THE CITY'S COMPREHENSIVE PLAN; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

Pinal Gandhi-Savdas, CRA Executive Director, presented a brief introduction of the East Stuart Neighborhood Small-Scale Future Land Use Maps Amendment and read Ordinance No. 2500-2023 for the record.

City Attorney, Mike Mortell, reported via ZOOM, that Commissioners are to be sworn in on all Future Land Use items.

2. EAST STUART NEIGHBORHOOD - ZONING MAP AMENDMENT (RC):

ORDINANCE No. 2499-2023; AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, AMENDING THE CITY'S OFFICIAL ZONING MAP TO ASSIGN "EAST STUART NEIGHBORHOOD" ZONING AND MAKE CHANGES FOR CONSISTENCY WITH FUTURE LAND USE MAP; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

Ms. Seymour presented the East Stuart Neighborhood Zoning Map Amendment updates to Ordinance No. 2499-2023 and reviewed with the Commission the changes made since the Local Planning Agency (LPA) Meeting, which included a demonstration of the color coded map, showing the code updated in removing the commercial component, which provides more flexibility and single-family homes in the area, thoroughfare types, density, and timeline.

Ms. Seymour listed top 3 takeaways:

1. Allowing residential on BMU
2. Reflecting lot sizes and historic building in setbacks
3. Additional opportunities for community input.

Commissioners had discussions and asked Ms. Seymour questions about the below:

- Sidewalks
- Code Updates
- Dwelling Units
- Historic Preservation

- Building Types
- Neighborhood Open Space
- Stemwalls

PUBLIC COMMENT:

1. Frank McChrystal - Stated that he hopes that the accessory dwelling unit rule will be used throughout the City and not just East Stuart.
2. Jimmy Smith - SE Apache Ave; Thanked the Commission for what they're doing and caring for the historic community, stated that East Stuart is a special community.
3. Joseph Cooper - 9th St; Stated that it was important to create an overlay for East Stuart and thanked the Commission for doing this.

ORDINANCE No. 2502-2023; AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, AMENDING THE FUTURE LAND USE MAP OF THE CITY'S COMPREHENSIVE PLAN THEREBY CHANGING THE FUTURE LAND DESIGNATION FROM "COMMERCIAL" TO "DOWNTOWN" FOR 20.07 ACRES OF LAND AND "DOWNTOWN" TO "RECREATION" FOR .25 ACRES OF LAND AS DEPICTED IN EXHIBIT "A" ATTACHED; DECLARING THE PLAN TO BE CONSISTENT WITH THE CITY'S COMPREHENSIVE PLAN; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

Ms. Seymour continued with her presentation on Ordinance No. 2502-2023 on the Creek District, Small-Scale Future Land Use Amendment with a proposed map, reviewing the

details and recommended action.

Commissioner Collins asked if we were creating 3 new sub-districts, in which Ms. Seymour answered it was creating 3 new zoning designations.

Ms. Seymour presented briefly on the proposed land development regulations, comments from LPA and CRB, proposed regulating plan, proposed development standards, uses, density, proposed frontage types, existing and proposed parking standards, proposed thoroughfare plan, proposed low impact development standards, and neighborhood open space.

Commissioners are in consensus about changing the language that refers to the subdistrict for second reading of items.

Commissioners had a discussion about formula retail and corporate advertising, and would like to have staff come back with more information and review the language.

Commissioners continued discussion with Ms. Seymour about the Ordinance and The Creek District.


