# PRESENTATIONS

### **10.** CITY OF STUART DRAFT STRATEGIC PLAN

Jim Karas, Consultant, Planner/Facilitator, presented the Strategic Plan process that was recently performed with the Commission and City leadership staff. The presentation

reviewed "how did we get here?", the elements and style, goals and performance measures, charting a vision, and action strategies. Mr. Karas recommends the City participate in a full Charette to review the issues that have been discussed for years, ie: parking, name branding for neighborhoods, City Hall location, and more. Mr. Karas reviewed health and public safety, support of St. Lucie River and the financial status of Memorial Park final phase with Ampitheater, complete Guy Davis "Central" Park, rebuild of Central Community Center and a living shoreline along Flagler Park. Mr. Karas ended with Goals for Financial Security.

Commissioner Clarke thanked Mr. Karas and asked about a monetary plan which encourages to match certain goals. It was explained that every item includes an estimated cost/price and if it does not show a funding source that's more definitive, the best analysis is provided.

The Strategic Plan will be brought back before the Commission at the first meeting in June.

### COMMENTS BY CITY COMMISSIONERS

Vice Mayor Bruner

 Commented on her attendance of the "Meet Frederick Douglas in the Park" at the Old Salerno Colored School House and the history of such buildings; local Historian, Julie Priest, attended as well and expressed concern about the Commission and Community continuing to recognize the history of Stuart and would like those now and after them to remember it.

**Commissioner Clarke** 

- Announced the Historic Preservation Month kick-off on May 1st at the Stuart Feed Store, to recognize the naming of Luckhardt Lane; Mr. Luckhardt has been busy, but we have dedicated a lot to Alice, honoring Alice and Loyde Jones as the first black person in the County to be recognized as a Martin County historian.
- Commented on the Emancipation Day Proclamation and noted it is being celebrated on May 20th each year and at Mars Hill in Jensen Beach, there will be a Church service at 11 a.m., also at the Friendly Hearts Community Garden, County Line Road at 1:00 p.m.
- Mount Calvary Baptist Church is celebrating their 109th birthday at 11 a.m., May 21st.
- Requested whether there will be a Shade Meeting on the trial or other lawsuits.

Interim City Manager Mortell said that the trial (North Point) is beginning tomorrow and provided a brief explanation; a settlement discussion could occur but only if there is a global solution for all water providers involved. The PFOA case is pending and it does not look like there will be a settlement before it starts on June 4 in Charleston, SC. Another pending case is the Cartwright Appeal.

Commissioner Clarke continued to further state that she attended the Ethic Session and gave a very big compliment to the City Clerk, Mary Kindel, about her involvement and commitment to the City of Stuart along with her commitment to her daily activities as the City Clerk.

Interim City Manager followed up on a statement Commissioner Bruner made with regard to buying a table at the Flagler Center 80th Anniversary Celebration. Direction is needed from the Commission.

Commissioner Rich

- Cookies with Rookies, had the opportunity to meet the newly hired Deputies and Firefighters.
- Read from a prepared statement pertaining to Robert's Rules and Procedure. Specifically, Section 2-54 under Parliamentary Rules in our Ordinance signifies that the City Commission shall follow Robert's Rule of Order for the conduct of its meetings. The number one rule of any meeting is the Chair (Mayor) controls the floor. No member may speak unless recognized by the Chair and may not speak twice with a single motion. Commissioner Rich suggests we adhere to this more strictly moving forward. Also commented that all Commissioners be recognized in order. This should be an opportunity to demonstrate that our discussions can proceed smoothly, fairly and respectfully, even when decisions are contentious ones. That is the basis of democracy.

### Mayor McDonald

- Attended the MPO state meeting in Orlando and reported that they indicated that new legislation is coming to protect municipalities from a transportation perspective. SB1604 addressing Land Use and Development regulations, the EAR amendment process, removed the ability to lose architectural control of projects. There are penalties for failing to change some of these amendment periods that the Mayor showed concern over.
- Reported on something that came out of the legislation, MPO is required to work with SpaceCoast to improve transportation.
- Commented on the Police Memorial Ceremony Day and not being able to attend as he will have an MPO Meeting.
- Ethics class, new Financial Disclosure Forms.
- Announced that he participated in the National Day of Prayer.

Interim City Manager Mortell

- Commented on the Senate Bill and has not had an opportunity to review it all, but noted that it is his understanding that it is a retaliation bill that came from Reedy Creek and referred to Page 12 and provided interpretation and clarification.
- Mayor McDonald commented that he has attended the court proceedings and is glad Mike is on our side. He is a skilled litigator.

### DISCUSSION AND DELIBERATION

### **13.** LIVE LOCAL ACT 2023 (SB 102)

Jodi Nentwick-Kugler, Development Director, presented the background, purpose and intent, including eligibility for the Live Local Senate Bill 102 that will be effective July 21, 2023. The Department is requesting input on the procedures for implementation of the Live Local Act.

Commission discussion included looking into the City codes and the passing this before July 1st.

- LPA in June, first reading to the CCM at the end of June adopted in July.
- The statute takes place on July 1st but noted the Development Director would create a
  policy for adoption to make it easier for the public. In addition, how the taxation or ad
  velorum applies, though we don't set the tax rate, the purpose of the language is for
  explanatory purposes.

Mayor McDonald noted that the DEO will be implementing a series of rules and we will have to deal with that.

Commissioner Clarke commented on reviewing the current policies. Are we going to CRB and LPA to get their input on policies?

Interim City Manager Mortell commented that the law states that no provisions can be made.

Commissioner Clarke asks if CRB can be invited to the meeting.

Commissioner Rich commented that we need to become experts in this law.

Interim City Manager Mortell provided insight.

### PUBLIC COMMENT:

 Nick Blount - Sandpiper Lane; Chair of Housing Solutions Council. An item related to this Senate Bill 102 is that on June 22, right before the bill goes into effect, our organization in conjunction with Treasure Coast Regional Planning Council is conducting a Housing Summit at Indian River State College from 8 a.m. to 12 p.m. There will be representatives from the Florida Housing Coalition as well as other people around the State that have an interest in Affordable Housing. This will give an opportunity for questions to be answered.
